#### *#NoSilenceOnEDViolence: Enacting Bulletproof Policies & Legislation*

Half of reported workplace violence occurs in the healthcare setting. In 2018, half of emergency physicians reported having been physically assaulted on the job. It's time to stop violence in the ED by changing policy to keep us safe! We'll discuss staggering statistics regarding violence in our EDs as well as emergency department and hospital policies put in place to reduce healthcare provider assault. We will review model state legislation aimed to reduce workplace violence in healthcare, the Workplace Violence Prevention for Health Care and Social Service Workers Act, (HR 1309) passed by the US House in Fall 2019, and the next legislative steps to protect and defend emergency clinicians from violence in the workplace.

- Explain the nature of workplace violence in healthcare, particularly in emergency medicine, risk factors that may contribute to increased violence, and the vast underreporting of workplace violence within hospitals.
- Discuss effective practices and policies developed by hospitals and emergency departments leading the way in reducing violence perpetrated against healthcare providers and how to champion administrative support for these innovations.
- Identify proposed or enacted state and federal legislation aimed to reduce healthcare or ED workplace violence and how to champion political support to counteract the problem.

#### *Tort Hot, Tort Cold, or Just Right: Would Goldilocks Practice EM in Your State?*

Malpractice reform, often known as medical tort reform, has been tackled in a number of states, but attempts at passing similar regulations on the federal level have failed since the 1970s. As of 2016, thirty-three states have imposed caps on any damages sustained in medical malpractice lawsuits. Is your state a physician friendly practice state? If not, what action should you and your physician colleagues take to protect yourself and your patients' access to care?

- Explore effects of tort reform; address cost malpractice insurance, cost of healthcare, access to care.
- Provide examples of actions physicians and physician organizations can take to enact or further medical malpractice reform on a state basis.

#### *#InsuranceFail: Surprise Billing Update 2021*

The issues surrounding the out-of-network/balance billing debates have engulfed clinicians, politicians & consumers from DC to Olympia. The increasingly narrow networks offered by the fewer & fewer health plans have decreased patient access and increased patient cost-sharing while increasing insurance company profits. The discussion will highlight existing state out-of-network billing legislation and an update on pending or enacted federal legislation.

- Briefly review the environmental landscape with key terms, concepts, disputed issues and areas of agreement amongst insurers, physicians, and consumers.
- Analyze strengths and weaknesses of out-of-network state legislation that has been effective in both protecting patients and providing clinicians a meaningful and accessible reimbursement dispute resolution process.
- Discuss successful lobbying & public relations strategies to achieve “win-win” solutions for patients & physicians including opportunities & threats resulting from pending or recently enacted federal legislation.

#### *Telemedicine Regulatory Changes Zooming to Your Practice*

The COVID pandemic has brought rapid regulatory changes to the practice of telemedicine. The speaker will discuss how HHS and CMS regulations, under the president's 1135 waiver and the Coronavirus Preparedness and Response Supplemental Appropriations Act, changed who can practice telemedicine, Medicare covered services, and HIPPA enforcement. In addition, licensure flexibility at state and federal level will be addressed. What, if any, of these changes can be expected to become permanent?

- Briefly introduce the role of Health and Human Services (HHS) Office for Civil Rights (OCR) and the Centers for Medicare & Medicaid Services (CMS) in telemedicine regulation.
- Review regulatory changes including, but not limited to, licensure and credentialing of telehealth providers, Medicare covered telehealth services, and HIPPA enforcement.
- Discuss what federal and state regulatory changes made as a result of the pandemic are expected to become permanent and their likely effects on the practice of telemedicine.
