- 6. Dr. Sarah Hoper, MD, JD, FACEP provided the ACEP21 Council Update. There will be a New Strategic Plan that focuses on physicians first. Attendees were told they could give their input at acep.org/strategic plan.
 - a. Resolutions
 - i. Workforce transparency
 - 1. Mandates non-physician providers to introduce themselves as non-physicians
 - a. NOT adopted
 - ii. Offsite Supervision of APPs
 - 1. Asked that ACEP no longer support offsite supervision of APPs
 - a. Referred

- iii. Reporting of injuries suspected or reported to be resulting from law enforcement action
 - 1. Establish best practices and a toolkit regarding the identification and reporting injuries suspected to be the result of law enforcement
 - a. NOT Adopted (213/209 votes)
- iv. Paid family and medical leave
 - 1. ACEP will advocate for paid leave, including supporting the AMA's effort to study FMLA
 - a. ADOPTED
 - 2. ACEP will develop a policy statement in support of paid family leave a. REFERRED
- v. Firearm ban in EDs, excluding active-duty law enforcement
 - ACEP will promote and endorse that EDs become firearm-free, endorse screening for weapons in EDs, and promote public education and academic research to reduce workplace violence
