Major Points Discussed

Call to Order, Opening Remarks - Dr. Haisler

-Dr. Haisler called the meeting to order at 9:36 AM and introduced the Section Officers and guests.

-Dr. Kang discussed his vision for the Air Medical Transportation Section, which includes finding issues and consensus, identifying future leaders and providing the college with section needs.

Newsletter Report/Call for Topics

- -Finding and submitting articles continues to be an issue. The section will consider the possibility of assigning multiple newsletter editors to assist the secretary. The secretary is the newsletter editor according to the section bylaws.
- -The ease and process of copyright procedures were discussed.

CAMTS Board Report - Dr. Guyette

-Dr. Guyette gave a brief description of CAMTS.

Councillor Report - Dr. Costa / Weis

-An overview was provided regarding of applicable council activities and resolutions.

Unified EMS DEA resolution supporting H.R. 4365 / S.B. 2932 Resolutions are in the house and in the Senate. Went to committee, DEA gave input but ran out of time in the legislative session. Hope is to have them pushed through in next session. Contact your legislator to support these bills.

-There was an update on DEA issues and the "Protecting Patient Access to Emergency Medications Act of 2016".

New Business-Dr. Haisler

<u>Section Communication</u>- The use of the Air Medical Transportation was encouraged to discuss current issues. It was noted that items discussed on other section listservers (e.g. EMS), do not often get shared on Air Medical. Physicians who are members of both can share items of interest.

Education Sessions for Scientific Assembly-

- -One Air Medical Transport education offering that was submitted was: "What to expect when expecting transport, how to choose transport and prepare for it."
- -The group discussed the submission of education offerings for the conference and what can be done to have more accepted. EMS education is limited at ACEP because it is not generalizable, needs to generate large attendance with positive reviews. Education committee members can submit until mid-November.

<u>Call for Council Resolutions</u>-The group discussed other issues in the industry particularly balanced billing and drafting a resolution to address it. Resolutions are due by July 15, 2017.
