Council Report

- Numerous resolutions discussed
- Dual training section- at least 1 dual trained physician at ACGME; debate on the floor did not go so well; per Dan Martin, "online testimony was more in favor"; in reference committee, more people spoke in favor.
- Gillian Schmitz felt strongly that ACEP should not be involved in RRC and took us to task.
- Vote to extract, followed by attempt at amendment, but the amendment did not pass and then attempt to refer to the board, but then was voted down.
- Need to decide how we can proceed; future discussions to come!
- Proposing the drafting of a white paper; concern about resolution dispelling myths about our training
- Working with Dr. McCrae, Cirillo to get time on agenda/advise re strategy; our board rep will.
- Council needs to be better informed about what dual training actually is.
- ACEP news to educate and inform councilors.
- Is there any way to get more information regarding ACEP and its relationship to RRC/ACGME?

- We have no control over the decisions that they make; all comments were submitted to ACGME
- o Do we need to have more meetings/representation with ACGME?
- o EM RRC recruiting? If so, can ACEP nominate someone or can we get someone experienced (like Martin, Tyo, Suri) to pursue this?

Report from Board

- Salt Lake City will now be in rotation as a site for ACEP in the future; previously not considered but Dallas was renovating.
- Quality measure shaming statement from Board
- DEI values will not change, even if wording changes to be in compliance with governmental.
- Adopted a new policy on gold standard for liability insurance

Is ACEP the optimal venue for discussing representation? Is ACGME, ABEM, etc better?

Mixed responses, but ACEP can deliver the white paper to ACGME, RRC.

White paper, ACEP Now to generate enhanced knowledge and reconsider repeat resolution potentially. Moving beyond 5 years as the death of combined programs, with which the RRC agreed. Should the white paper discuss contracts and compensation?

How do you start an EM/IM program?
