Dr. Wendy Macias Konstantopoulos gave a presentation on Human Trafficking and the Role of Emergency Medicine. Facts included:

- Labor Trafficking Is The Most Prevalent Type
- Case Studies On Faces Of Human Trafficking
- 63% of Survivors Sought Care In Ed
- Provider Barriers To Care Of These Patients In The ED include.
  - Lack Of Education For Health Professionals On Human Trafficking
  - Lack Of Reliable Data
  - Lack Of Policies And Protocols
  - Competing Issues/Resources

Dr. Goldhahn provided a Council Update, which included issues such as powered alcohol and marijuana legalization.
