Major Points Discussed

Dr. Anderson welcomed everyone and thanked the sponsors of the section meeting, the Emergency Medicine Foundation (EMF) and Leelyn Smith, LLC. He then asked Tony Velluci to provide an overview of EMF and ways that sections members could be involved in supporting the foundation.

Following Tony's presentation, Dr. Pattavina provided a report about the recent Council meeting, along with the results on the resolutions and Board, Council, and presidential elections.

There was a panel discussion on mentoring and coaching, led by Dr. Amanda Irish, Dr. RJ Sontag, and Dr. Nick Cozzi. The three panelists emphasized the following points:

- Casual mentor relationships are the best.
- Kindness matters.
- Make yourself relatable to younger physicians. Introduce yourself. Offer time. Share lessons learned.

- Encourage younger physicians to have a professional plan but hold it loosely and be open to other opportunities. Share those opportunities with younger physicians.
