# JOHN G. WIEGENSTEIN LEADERSHIP AWARD

## **Purpose**

The John G. Wiegenstein Leadership Award is presented to a current or past national ACEP leader – member of the Board of Directors or officer of the Council – for outstanding contributions to the College. The award is named after John G. Wiegenstein, MD, a founding member and the first president of ACEP. Dr. Wiegenstein represents the epitome of leadership, both personal and professional. He served for five years as the College's first delegate to the American Medical Association and he also served as president of the American Board of Emergency Medicine.

#### **Award**

The Wiegenstein Award is a walnut plaque featuring an etched portrait of the recipient. The recipient's name is inscribed on a master plaque at ACEP Headquarters. By virtue of receiving this award, the recipient is not required to pay dues or registration fees for the annual meeting.

## **Eligibility**

Any member of the College may nominate a past or current member of the Board of Directors or officer of the Council for this award. The nominee must be a regular member of the College.

#### Criteria

The nominee should have made an outstanding contribution to ACEP by significantly helping to achieve one or more of the College's purposes and objectives. The nominee should serve as a role model for College members, and his/her personal leadership attributes should include, but are not limited to: inspiration, innovation, diplomacy, planning, organization, management and administration, arbitration, consensus building, and decision making. **Recipients of this award are ineligible to receive awards in other categories of the Awards Program.**

# JAMES D. MILLS OUTSTANDING CONTRIBUTION TO EMERGENCY MEDICINE AWARD

## **Purpose**

The James D. Mills Outstanding Contribution to Emergency Medicine Award is presented to a regular member for significant contributions to emergency medicine. This award is named after the late James D. Mills, Jr., MD, the second president of the College. Dr. Mills practiced emergency medicine in Alexandria, Virginia, for many years, and is commonly referred to as a designer of the "Alexandria Plan" for staffing emergency facilities with full-time practitioners of emergency medicine.

#### Award

The Mills Award is a walnut plaque featuring an etched portrait of the recipient. The recipient's name is inscribed on a master plaque at ACEP Headquarters. By virtue of receiving this award, the recipient is not required to pay dues or registration fees for the annual meeting.

# **Eligibility**

Any member of the College may nominate a member for this award. The nominee must be a regular member of the College.

## Criteria

The nominee should have made a significant contribution to emergency medicine through a variety of avenues, including College committee service. Examples of significant contributions to the specialty include but are not limited to: improved patient care delivery modes, cost containment, quality of care improvements, disaster planning, improved EMS organization, and public education. **Recipients of this award are ineligible to receive awards in other categories of the Awards Program.**

# JOHN A. RUPKE LEGACY AWARD

## **Purpose**

The John A. Rupke Legacy Award is presented to a current College member for outstanding lifetime contributions to the College. In recognition of longevity and unwavering dedication to the College, the Legacy Award is given in honor of John A. Rupke, MD, one of the initial founding members of the College.

#### **Award**

The Rupke Award is a handblown glass sculpture featuring the ACEP logo and name of the recipient. The recipient's name is inscribed on a master plaque at ACEP Headquarters. By virtue of receiving this award, the recipient is not required to pay dues or registration fees for the annual meeting.

# **Eligibility**

Any member of the College may nominate a member for this award. The nominee must be a regular member of the College.

## Criteria

The nominee must have been a member of the College for more than 25 years, and during that time have served the College as an active leader making sustained contributions either in the local, state or national emergency medicine communities as a consensus builder, with humanitarianism, and as an advocate for the profession. The member must have also demonstrated exceptional commitment of time and dedication to emergency medicine and to improving the care of emergency patients. This devotion and persistence over such a span of time exemplifies the true spirit of what has shaped our specialty and infused it with enthusiasm and unstoppable drive. Recipients of this award are bestowed our appreciation and gratitude for their contribution in furthering our goal as a College to serve our members and the patients for whom they provide care. **Previous recipients of the Wiegenstein or Mills awards are not eligible to receive this award.**

# PAMELA P. BENSEN TRAILBLAZER AWARD

## **Purpose**

The Pamela P. Bensen Trailblazer Award is presented to a current College member for seminal contributions over time to the growth of the College and to the specialty of emergency medicine. The award is named after Pamela P. Bensen, MD, a charter member of ACEP and the first woman resident in emergency medicine (1971). She was also the first woman elected to the national ACEP Board of Directors and served from 1982-88. Dr. Bensen pioneered innovations in ACEP's governance, developed the first emergency medicine group and the first paramedic training program in Maine, and was an early adopter of data analysis to improve clinical care in the emergency department (1980s).

#### **Award**

The Bensen Award is a walnut plaque featuring an etched portrait of the recipient. The recipient's name is inscribed on a master plaque at ACEP Headquarters. By virtue of receiving this award, the recipient is not required to pay dues or registration fees for the annual meeting.

# **Eligibility**

Any member of the College may nominate a member for this award. The nominee must be a regular member of the College for 10 or more years.

## Criteria

The nominee should have made and achieved a number of seminal contributions and accomplishments to the growth of the American College of Emergency Physicians and to the specialty of Emergency Medicine through a variety of avenues, including but not limited to: clinical, organizational, administrative, educational, governmental, political, prehospital and other venues. These contributions and accomplishments should demonstrate foresight and leading-edge thinking, at times requiring courage to prevail over customary attitudes and methods, resulting in solid achievements. The nominee should have demonstrated these attributes repeatedly over a period of years. **Previous recipients of the Wiegenstein, Mills, or Rupke Awards are not eligible to receive this award. Recipients of this award are ineligible to receive awards in other categories of the Awards Program.**

# HONORARY MEMBERSHIP AWARD

# **Purpose**

The Honorary Membership Award is presented to an individual who has rendered outstanding service to the College or to the specialty of emergency medicine.

## **Award**

The Honorary Membership Award is a framed certificate. The recipient's name is inscribed on a master plaque at ACEP Headquarters. The recipient is considered a lifelong member of the College, is not required to pay any dues, and cannot vote or hold office but receives all other benefits and privileges of membership.

## **Eligibility**

Any member of the College, or any component body, may nominate persons of distinction who have rendered outstanding service to the College or to the specialty of emergency medicine. **Candidates for honorary membership cannot be currently eligible for other categories of College membership.** National ACEP staff are eligible for nomination only after leaving employment from ACEP. Chapter executives are eligible for nomination only after leaving employment from the chapter.

The nominee should have made an outstanding contribution to ACEP by significantly helping to achieve one or more of the College's purposes and objectives. The nominee should serve as a role model for College members, and his/her personal attributes should include, but are not limited to: inspiration, innovation, diplomacy, planning, organization, management and administration, arbitration, consensus building, and decision making.

# COLIN C. RORRIE, JR., PHD AWARD FOR EXCELLENCE IN HEALTH POLICY

## **Purpose**

The Colin C. Rorrie, Jr, PhD Award for Excellence in Health Policy is presented to a member who has made a significant contribution to achieving the health policy objectives of the College and/or who has demonstrated outstanding skills, talent, and commitment as an administrative or political leader. Dr. Rorrie served the College as Executive Director from 1982 to 2003 and was instrumental in encouraging and guiding the Board of Directors to develop and implement a strategic planning process with focused priority objectives. Additionally, he was instrumental in the development of ACEP's Washington office and in elevating the stature of emergency medicine's advocacy efforts. He understood the importance of ACEP's participation in a public policy agenda as it applies to emergency medicine and healthcare.

## **Award**

The Rorrie Award is a cherry plaque with a gold back plate, black center plate, and a gold brass top plate etched with the ACEP logo and the recipient's name. The recipient's name is inscribed on a master plaque at ACEP Headquarters.

# **Eligibility**

## EMERGENCY MEDICINE WELLNESS CENTER OF EXCELLENCE AWARD

# **Purpose**

The Emergency Medicine Wellness Center Excellence Award is presented to an emergency medicine group, department, or clinical site that incorporates wellness and resilience on an institutional level and to use the information gathered in the nominations process to understand more about wellness best practices.

#### **Award**

The Emergency Medicine Wellness Center of Excellence Award is a plaque, or similar item, awarded to an emergency medicine department, group, or clinical site that demonstrates wellness best practices and may be displayed at their location. The recipient organization's name will be inscribed on a master plaque at ACEP Headquarters.

# **Eligibility**

Any member of the College, or any component body, may nominate any emergency medicine department, group, or clinical site that demonstrates a commitment to both organizational wide and promotion of personal wellness and resilience among its emergency medicine physicians.

## Criteria

The Professional Well-Being Committee will evaluate all nominations submitted by the deadline. The nominee should demonstrate an institutional commitment to wellness and resilience and serve as a model to other organizations. Activities that are appropriate for evaluating nominations include but are not limited to:

- Significantly helped to advance the understanding of emergency medicine physician wellness.
- Developed specific identifiable wellness and resilience programs for physicians.
- Demonstrate engagement in physician wellness and resilience at all levels of leadership.
- Examples of significant wellness practices may include, but are not limited to, having an assigned wellness officer or champion,
- Offer a variety of wellness programs in different domains of wellness,
- Offer both institutional level and individual level programs and support for physician wellness and resilience.
- Employing formal methods of evaluating the wellness and resilience programs in place.

# **Entry Procedures and Selection Process**

Any ACEP member who wishes to nominate a candidate should complete a nomination form and outline the nominee's wellness best practices. Submit the nomination form, nominee's curriculum vitae, and up to three letters of support through the online form located on the ACEP website. Letters of support are greatly encouraged and are at the discretion of the nominator. Additionally, a nominee should have only one nomination whether from an individual or from a chapter, committee, section, or individual. All entries must be submitted no later than the publicized deadline. Receipt of each nomination will be confirmed by email. Please follow up if you do not receive a confirmation.

## **Judging**

The Professional Well-Being Committee will judge the entries with its recommendations subject to review by the ACEP Board of Directors. The decision of the Board is final, and the Board reserves the right to make no award if there are no nominees of sufficient merit. The Board may also decide to grant the award to more than one recipient.
